Olton Independent School District is requesting proposals for Internal Connections to be delivered to the following location (no installation required).

The school presently employs a robust network infrastructure, they would like to replace the firewall. Olton ISD is a small rural school district that serves approximately 591 students. Olton ISD's I.T. team will install and configure the new equipment requested in this RFP/RFQ.

All bidders must be authorized resellers of networking equipment and capable of managing Cisco/Aruba infrastructure. Eligible vendors must be registered with the Universal Service Company and agree to submit a Service Provider Annual Certification (SPAC) with USAC.

Service Requirements

The applicant prefers a single-vendor solution where the contracted vendor supplies networking equipment only. Quantities requested in this RFP and 470 are estimates only, the district is requesting per-unit pricing. The quantities cited below are estimates that will be required for the 2025/2026 fiscal year.

The school wishes to purchase the following equipment:

Bids will be accepted from different manufacturers if the bidder can demonstrate that the equipment is equivalent to the requested equipment.

Contract Term

The initial contract term is one year beginning on July 1, 2025, and expiring on June 30, 2026. The contract can also include two, one-year voluntary extensions. The maximum contract period shall not exceed July 1, 2024, to June 30, 2027, including all extensions.

Proposal submissions shall cite the associated Form 470 number and applicant name.

Proposals must include all costs associated with providing service, including but not limited to:

- Cost of equipment and required software/licenses
- Installation/activation/and configuration
- estimated taxes, fees, and/or surcharges
- Cost associated with additional support warranties

Proposals that do not provide definitive costs for the services requested (including recurring and/or one-

time charges) will be considered non-responsive and will not be included in the evaluation.

Proposals that include generic/encyclopedic price lists will be considered non-responsive and will not be included in the evaluation.

Proposals should include the service provider's terms and conditions.

Proposals shall include the service providers identification number (SPIN)

Proposals submitted after the bid submission deadline will be considered non-responsive and will not be included in the evaluation.

Required Notice to Proceed and Funding Availability

The school will follow its purchasing policies and requirements and procedures of the FCC's E-Rate program as administered by USAC to be eligible for all available funding. The implementation of any associated contracts resulting from this competitive bid process will be dependent on the school's issuance of a written Notice to Proceed. E-Rate funding notification alone will not signify Notice to Proceed. The school will have the right to allow the contract to expire without implementation if appropriate funding is not available.

Other

Per USAC E-Rate guidance, "cost of eligible services" will be the highest valued criterion in the evaluation process; however, other criteria with a lesser value may also be considered.

Bidders shall document the ability to participate in the E-Rate program by supplying their current SPIN (Service Provider Identification Number) as part of their proposal.

Proposals for multi-year contracts and contracts with voluntary extensions are encouraged.

Subject to contract restrictions, services may be reevaluated for cost-effectiveness at any time during the life of the agreement.

Service providers proposing equipment whose prices may increase depending upon new U.S. government tariffs imposed on foreign imports are encouraged to (a) identify such products in their offers, and (b) propose an acceptable methodology for limiting price adjustments over the life of the contract.

Service providers proposing to temporarily loan equipment for product demonstration and/or evaluation purposes are required to clearly state that such loans are of limited duration. Product demos extending beyond thirty (30) days must be explicitly authorized by both parties and provided at a fair market rate.

By submitting a proposal on the requested services herein, the vendor certifies that its equipment and services are compliant with the FCC's recent Order (FCC 19-121) prohibiting the sale, provision, maintenance, modification, or other support of equipment or services provided or manufactured by Huawei, ZTE, or any other covered company posing a national security threat to the integrity of communications networks or the communications supply chain.
